**VI. Related costs of withdrawing from the program**

For the student who withdraws before the start of the school year or before the end of the school year, the following fees for the upcoming school year will apply :

Before June 30 (15%)	\$1,200
Between July 1 and registration day (20%)	\$1,600
Between registration day and November 30 (50%)	\$4,000
After November 30 (100%)	\$8,000

**VII. Consequences of non-payment**

As a parent, I commit to respect the payment schedule. In case of non payment, the parents must supply a revised schedule and have it approved by the CÉF. If no solution is reached, the conditions of the tuition agreement will apply and the child will be returned home at the parents' expense.

**VIII. Transportation to and from the home:**

The parent or guardian, is responsible for the costs at any time and to collaborate in organizing transportation during school breaks and holidays and medical appointments.

If a child is sent back home for disciplinary reasons, the parent will be responsible for organizing transportation and will assume the costs.

**IX. Methods of payment:**

Parents can remit payment to the Conseil scolaire fransaskois by personal post-dated cheques for the required amount at admission. The other payments may be made by certified cheque or arrangements can be made for monthly Automatic Debit (Form A-39).
